History and Overview


The Morgan Hill Fire Department was established on January 17, 1907, by ordinance #14 of the Morgan Hill City Council and disbanded in 1995. Fire Protection Services were provided by the Santa Clara County Fire Department from 1995 to 2013.

In January 2013, Morgan Hill reconstituted its fire department, ending a contract with Santa Clara County Fire Department and entered into an agreement with the California Department of Forestry and Fire Protection (CAL FIRE) to provide staffing and administrative services for both fire protection and emergency medical services within the city.

Morgan Hill's fire personnel works a 66-hour shift and are currently quartered at 3 stations. Our highly trained and motivated firefighters provide emergency services for residential, commercial and wildland firefighting; medical emergencies; automobile and technical rescue; and other hazardous conditions.

The department is proud of its abilities to provide services for all emergencies that arise in the area with an Insurance Standards Office (ISO) rating of Class 3 on the valley floor and Class 3X in areas more than 5 miles from the nearest fire station or more than 100 feet from the nearest fire hydrant.



FIRE MARSHAL'S OFFICE

The Morgan Hill Fire Marshal's Office provides technical information, advice and recommendations regarding enactment, amendment, repeal, and enforcement of fire prevention and suppression ordinances and regulations within the City. In cooperation with the City, the Fire Marshal's Office enforces and provides services required by the Morgan Hill Municipal Code and mandated by the State and Federal government, including brush abatement inspections in the Wildland Urban Interface.

The Fire Marshal's Office is committed to the protection of life and property through the development and application of fire prevention engineering, education and enforcement.

The Morgan Hill Fire Marshal's Office provides planning input for developers, plan checking and inspection services at the various levels required by the City of Morgan Hill. Plan checks for all specialized fire detection and suppression systems are performed by outside resources, while the inspection of these systems is performed by the Fire Marshal's Office personnel and recorded through our Streamline program.



By ensuring the enforcement of all fire prevention laws, regulating the use and maintenance of buildings, codes, and ordinances relative to the protection of life, property, and the environment from fire and unauthorized or accidental hazardous material releases the Morgan Hill Fire Marshal's Office makes the community a safer place for everyone.



TRAINING & EMS BUREAU

Training Bureau

The Training Bureau is responsible for providing continuous professional training, education, and certification to all personnel. Trainings are focused on providing and maintaining the highest level of quality emergency service for both fire and medical responses to the residents of Morgan Hill. Instructional programs provide operational efficiency with an emphasis on safe operating procedures for our personnel in all aspects of fire and emergency operations.



Emergency Medical Services (EMS) Bureau



The EMS Bureau is a very dynamic and constantly evolving program, with EMS responses accounting for over 73% of all incidents. The bureau is led by one Battalion Chief, who oversees approximately 14 Paramedics, and 10 Emergency Medical Technicians (EMTs) assigned to Morgan Hill.

It is the responsibility of the EMS Bureau to ensure all EMTs and Paramedics are in good standing with all certifications and licenses, as well as ensuring that they are delivering the highest level of professional EMS services.
