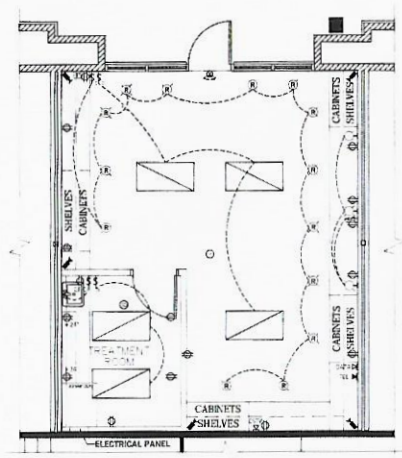
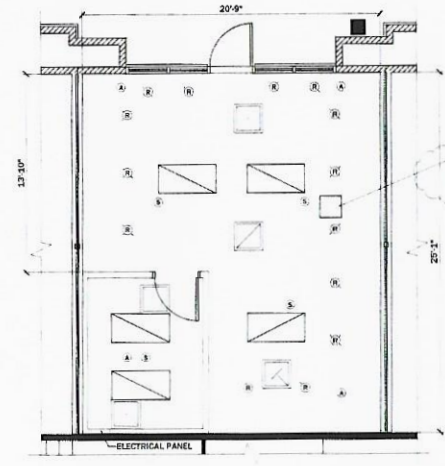

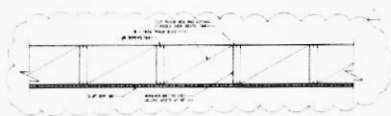

1 PROPOSED POWER, ELECTRICAL, TEL, & DATA PLAN



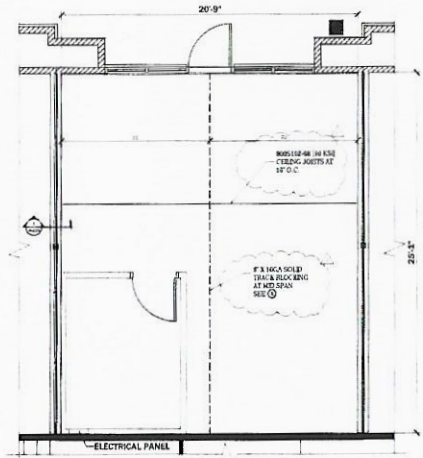
3 PROPOSED RCP



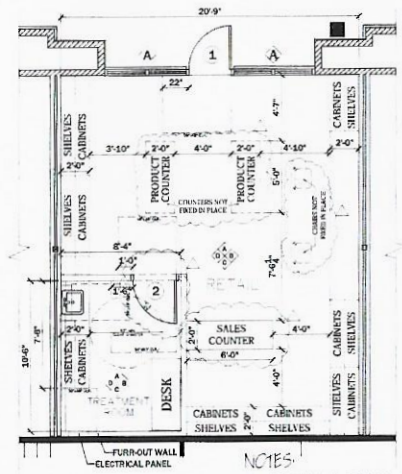
A TRACK BLOCKING
