



## Community Meeting #1 Post-it Notes Summary

### Vehicle Speeding/Safety Hot Spots

**Purpose** – Identify street segments on which speeds regularly exceed posted speed limits or have physical attributes that warrant reduction in posted speeds.

**Requested Input** – Red dot to indicate a speeding issue, yellow dot to indicate location of observed accident or near-miss, and post-it to note other streets and safety concerns.

## Comments

- Lots of new housing at Madrone/Monterey, Tilton. Family RV
- Sideshows on Monterey. High school speeding
- Excessive speeding on Dunne
- High speed at the turn near Flaming Oak Lane, up and down
- Residents have sign on Elm saying "This is NOT a freeway"
- High speed up Dunne with issues of cars pulling out of Gallop or making U-turns
- E Main in front of Live Oak HS high speed all day
- People in Jackson Oaks and Holiday need another egress down the hill, especially in fire or earthquake
- Single road into and out of Jackson oaks, holiday lakes, ridge estates. Need another road into and out
- speeding on Monterey Rd from regional traffic
- People do not stop at stop signs
- In neighborhood areas, cars do not stop at stop signs
- Fire safe council. Want signs for evacuation route. Issue dynamic (E signs?). Issue flood, wildfire, earthquake
- (same as ped). Right turn on red at arterial especially Tennant/Butterfield. Ped on NW/NE corner driver looking other way for gap.
- Cochrane – multiple houses had car crashes in fences and front yards
- E Main overpass 101 at Condit. Bike/Ped crossing sight line coming over overpass.

## Transit Service Origin/Destination

**Purpose** – Identify locations you travel to in MH destinations (schools, shopping, work, etc.) that could be potential transit destinations and underserved areas of the City.

**Requested Input** – Red dot to indicate destination point in MH for which use of transit would be considered once per week (select up to three), orange dot to indicate origin point (your home) for which use of transit would be considered once per week, and post-it to note other areas currently underserved by transit and service frequency concerns.

- Dunne Ave/Jolene Way
- Shopping plaza at Cochrane Rd/DePaul Dr

### Orange Dot

- Midway on Peebles Ave
- Monterey Rd at Madrone Pkwy, at Wright Ave, at DT district, at Tennant Ave, and at Vineyard Blvd
- Near Dunne Estates Park
- Tennant Ave at Caputo Dr and at Hill Rd
- Hill Rd/Barrett Dr
- Dunne Ave/Flaming Oak Lane

## Comments

- People leave Rite Aid at 5 am to get to Chialas Farm to arrive to work at 7am
- Frequency of Caltrain is an issue
- "I have to walk from Hill/Tennant to St. Catherine. Its not safe. We need sidewalk"

## Pedestrian Conditions

**Purpose** – Identify gaps in sidewalk network and crossings/intersections that make it difficult to access primary destinations in the City.

**Input** – Green dot to indicate sidewalk gap, red dot to indicate desired crosswalk location, and post-it to note other concerns related to pedestrian conditions in the City.

- Monterey Rd at Madrone Pkwy, near El Toro Fire Station, between Ciolino Ave and Bisceglia Ave, and at Edmunson Ave
- Near W Main Ave
- Near Nob Hill Trail Park
- West end of Spring Ave
- Tennant Ave east and west of Church St
- Jolene Way
- Dunne Ave at US 101 and north of Flaming Oaks Ln
- Sutter Blvd/Serene Dr
- Butterfield Blvd/Sutter Blvd
- Main Ave/US 101 and Main Ave/Elm Rd
- Mission View Dr/Half Rd
- Cochrane Rd/Purissima Way
- Hill Rd from Main Ave to Dunne Ave and Fountain Oaks Drive to Tennant Ave

### Red Dot

- Monterey Rd at Tilton Ave, south of Burnett Ave, at 1<sup>st</sup> St, at Dunne Ave, at Cosmo Ave, and between Cosmo Ave and Tennant Ave
- Main Ave east of Hale Ave and at Del Monte Ave
- Diana Ave and Rosemary Cir
- Vineyard Blvd/LaCrosse Dr
- Cochrane Rd at Sutter Blvd, and east of Peet Rd
- Midway on Condit Rd between Dunne Ave and Tennant Ave
- Dunne Ave/Holiday Dr
- Dunne Ave/SB and NB on-ramps

### Comments

- Blind turns with lots of pedestrian activity
- Lots of new housing going here (Monterey, Madrone, Tilton, Burnett)
- Cochrane: Peet to Mallaguerra/Coyote
  - No sidewalk on north side
  - Residents cross Cochrane to south side
- Peet/Cochrane – no crosswalk
- Mallaguerra/Cochrane – no crosswalk
- Sports center to hotel
- Dunne, Tennant crossing over 101 is dangerous. (this got a +1 from another community member)
- Hale + Wright – no sidewalk too many kids in that area
  - Monterey/Watsonville
- J walking on Monterey near Panaderia Ortiz
- Right turn on red especially at Tennant/Butterfield. NW and NE. Drivers fixated on SE or NW gap and not looking for ped.

## Existing Bikeways and Trail Networks

**Purpose** – Identify gaps in the bikeways and trails network to primary origins/destinations (schools, shopping, work, etc.) and underserved areas of the City.

**Input** – Red dot to indicate priority location for new/improved bike facility, green dot to indicate priority location for new/improved trails facility, and post-it to note other concerns related to biking and trail access in the City.

- Cochrane Rd/Coyote Rd
- Hill Rd/Main Ave
- Murphy Rd between Dunne Ave and Barrett Rd
- Diana Ave/Lotus Way

#### **Comments**

- Bike lanes through DT
- All Monterey needs bike and pedestrian facilities
- Murphy area needs improvements
- “It’s not safe to bike anywhere in MH”
- Unsafe for kids walking and biking near school
- Trails have no shade and paved black asphalt

## **High Occurrence Crash Locations**

**Purpose** – Identify locations within the City that you perceive to be dangerous when driving, walking, and biking.

**Input** – Green dot to indicate location where you feel unsafe driving, red dot to indicate location where you feel unsafe walking/biking, and post-it to note other comments/concerns.

- Monterey Rd at Burnett Ave, at Cochrane Rd, south of Dunne Ave and Tennant Ave
- Del Monte Ave/Wright Ave
- Main Ave/Del Monte Ave
- US 101 at Burnett Ave and at Cochrane Rd
- Cochrane Rd/ Mission View Dr
- Mission View Dr/Half Rd
- Peet Rd/Avenida De Los Padres
- Main Ave at Montoya Cir, at Laurel Rd, at Condit Rd, and at Elm Rd
- Dunne Ave at Butterfield Blvd and at Holiday Dr

- Hill Rd south of Dunne Ave and north of Tennant Ave

#### **Red Dot**

- Monterey Rd at Burnett Ave, at Cochrane Rd, at Old Monterey Rd and at Main Ave
- Butterfield Blvd at Cochrane Rd, at Jarvis Dr, at Dunne Ave, and at Tennant Ave
- Cochrane Rd at US 101 NB off-ramp, at Peet Rd, at Malaguerra Ave, at Coyote Rd
- Hill Rd at Main Ave, at Pear Dr, at Dunne Ave, at Barrett Ave, south of Tennant Ave
- Dewitt Ave north of Edmundson Ave and at Spring Ave
- Dunne Ave at US 101 NB off-ramp, at Claret Dr, and at Thomas Grade
- Vineyard Blvd/La Crosse Dr
- Tennant Ave at Railroad Ave and at Condit Rd

#### **Comments**

- Thomas Grade very unsafe for pedestrians
- No sidewalks by Live Oak and Condit
- Ped crossing at on-ramp. 1<sup>st</sup> car stops and worried 2<sup>nd</sup> car will rear-end
