CCW License Firearm Qualification Standards

Upon Completion of a 16-hr. Initial or \geq 8 hr. Renewal CCW Training Classes

- 35 Round Qualification
- Passing Score: 85% or better (30 out of 35) shots land within the 7-ring or better
- Target: NRA Standard B-27 Silhouette
- A Maximum of 3 firearms may be listed on a CCW License, with the applicant qualifying with each firearm.
- Only the following calibers are accepted: .38, .357 (MAG okay), .380, 9MM, .44 (Special & MAG Okay), 10MM, .40, .45

All course of fire will start from a concealed carry position: firearm is concealed from public view.

3 YARD LINE

- 1) Applicants will stand at the three (3) yard line with their hands down at their sides.
 - a. At the command of "THREAT", the applicant will draw their firearm from a concealed location and fire two (2) rounds within five (5) seconds.
 - b. The applicant will remain in a low ready position until given the command to holster and reset.
- 2) Applicants will complete this course of fire five (5) times for a total of ten (10) rounds.

5 YARD LINE

- 1) Applicants will stand at the five (5) yard line with their hands down at their sides.
 - a. At the command of "THREAT", the applicant will draw their firearm from a concealed location and fire two (2) rounds within six (6) seconds.
 - b. The applicant will remain in a low ready position until given the command to holster and reset.
- 2) Applicants will complete this course of fire five (5) times for a total of ten (10) rounds.

7 YARD LINE

- 1) Applicants will stand at the seven (7) yard line with their hands down at their sides.
 - a. At the command of "THREAT", the applicant will draw their firearm from a concealed location and fire two (2) rounds within seven (7) seconds.
 - b. The applicant will remain in a low ready position until given the command to holster and reset.
- 2) Applicants will complete this course of fire five (5) times for a total of ten (10) rounds.

15 YARD LINE

- 1) Applicants will stand at the fifteen (15) yard line with their hands down at their sides.
 - a. At the command of "THREAT", the applicant will draw their firearm from a concealed location and fire five (5) rounds within ten (10) seconds.
 - b. The applicant will remain in a low ready position until given the command to holster and reset.
- 2) Applicants will complete this course of fire one (1) time for a total of five (5) rounds.

- 35 Round Qualification
- Passing Score: 85% or better (30 out of 35) shots land within the 7-ring or better
- Target: NRA Standard B-27 Silhouette
- A maximum of 3 firearms may be listed on a CCW License, with the applicant qualifying with each firearm.
- Only the following calibers are accepted: .38, .357 (MAG okay), .380, 9MM, .44 (Special & MAG Okay), 10MM, .40, .45
- The applicant is required to safely load, unload, and reload their handgun during the course of fire.

Qualification through the course standards is required for all firearms the applicant is intending to list on their CCW license.
