PUBLIC STREET VACATION APPLICATION COMPLETENESS CHECKLIST

APPLICATION PURPOSE

Vacation of a public street: the complete or partial abandonment or termination of the public right to use a street, highway, or public service easement, per the streets and highway code. The area vacated would then revert to the owner of the underlying fee interest for their own use. Staff will prepare report(s) for the required public hearing(s) for City Council approval.
