



PRIVATE SANITARY SEWER COLLECTION SYSTEM (PSSCS) INSPECTIONS REPORT FORM

Checklist to complete the Private Sanitary Sewer Collection System Inspection.

Private Sanitary Sewer Collection System (PSSCS):

- The inspection must be conducted by a Qualified Contractor from the City provided List of Qualified Contractors.
 - Per Ordinance No. 2322, a Private Sanitary Sewer Collection System Inspection must be completed by a Qualified Contractor (Licensed Plumber [C-36] with the State of California, has a City of Morgan Hill Business License, and is NASSCO Certified). Please see the list provided on the website (link below).
- CCTV footage of each lateral line, as well as the main sewer line running through the development must be completed by a Qualified Contractor to the city main connection. A map detailing the layout of the system must be provided by the plumber. The map must label each lateral line and correlate them to the CCTV footage provided.
- All lines on the report must be filled out and signed by the Property Owner/Property Manager and Qualified Contractor.
- If repairs are needed, obtain all necessary permits from the Building Department or Engineering Department:
 - Email - permits@morganhill.ca.gov
 - Phone - 408-778-6480 (press 1)
- After repairs are complete, conduct a new inspection by a Qualified Contractor to pass inspection.

Submission Checklist:

1. Complete PSSCS Inspection Report Form
 - Check that all fields are filled out by the Property Owner/Property Manager and Qualified Contractor.
2. CCTV video inspection with address, date, and time stamp.
3. Submit this completed document to PSL.WC@morganhill.ca.gov for review and request a Dropbox link to upload CCTV.


