#### **AAE2022-0008(ZA2019-0016)/EA2022-0011: ROSEWOOD (LILLIAN COMMONS) MEDICAL**

**CAMPUS:** Request for Zoning and Planned Development (PD) Master Plan Amendment to change the Rosewood (Lillian Commons) Medical Mixed-Use Master Plan to increase the allowable medical/commercial square footage to a total of 275,000 square feet, allow building heights up to 65 feet tall, adjust building coverage and parking standards, and expand permitted uses to include assisted living facilities, skilled nursing facilities, residential care facilities, and other community-serving uses. The properties, identified by Assessor Parcel Numbers 817-09-040 and 817-09-057, are located south of Juan Hernandez Drive and Barrett Avenue (Sutter Health Medical Foundation, Applicant).
